



RIMS Government Affairs program ensures that risk professionals' voices are heard upon the development, implementation and continuation of regulation that directly impacts the profession.






In late-2021, RIMS re-opened the doors to its in-person events and held a successful RIMS Enterprise Risk Management Conference in New York.


